Privacy Policy

- Data may be retained for the performance and running of Coláiste Chiaráin Courses (student progression and history during their time with Coláiste Chiaráin) for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, operational or reporting requirements.
- Data may be retained in order to contact you with regards to Alumni Activities and Other Courses developed and provided by Coláiste Chiaráin. We may share personal information held about you only within Coláiste Chiaráin for legitimate purposes only.
- Parents who have signed up a child to Coláiste Chiaráin are currently part of our database because you have signed up to attend a course with us. On that basis, we have a legitimate interest basis to contact you. We will never share, sell, or divulge any of your personal information.
